CALL FOR NOMINATIONS OF IAMM AWARDS & PRIZES 2016

(Last date of receipt of all nominations July 31, 2016)

1. Dr SC Agarwal Oration 2016: This award is supported from the interest incurred from a fund donated by Dr SC Agarwal, to be given to a senior member of the association for his /her outstanding contribution to the field of Medical Microbiology. Nominations for the award, duly proposed and seconded with the consent of the nominee along with consent of the nominee along with six copies of his/her biodata should reach the IAMM secretary's office on or before 31st July 2016. The award carries a citation and a gold medal. The selected candidate must be prepared to deliver the oration at the National IAMM Conference held in 2017. Nominations must come by post/courier as a hard copy by the last date. Nominations received by fax or email will not be accepted.

2. Dr. H.I. Jhala Memorial award 2016; This award is given to a senior member of the association above the age of 50 years, who has made significant contribution to the development of Medical microbiology in India. This award is supported from the interest from the fixed deposit donated by the organizers of the IAMM congress held at Sholapur in 1983. Nominations for the award, duly proposed and seconded with the consent of the nominee along with consent of the nominee along with six copies of his/her biodata should reach the IAMM secretary's office on or before 31st July 2016. The award carries a citation and a gold medal. The selected candidate must be prepared to deliver the oration at the National IAMM Conference held in 2017, if required. Nominations must come by post/courier as a hard copy by the last date. Nominations received by fax or email will not be accepted.

3. IAMM Endowment lecture award 2016: This award is supported by the annual interest obtained from the fixed deposit, donated by the organizers of the IAMM congress held at Hyderabad in 1985. This award is given to an eminent Medical Microbiologist, over the age of 50 years from India and abroad for their outstanding work in the field of Medical Microbiology, Bacteriology, Virology, Mycology, Parasitology/ Immunology/Epidemiology/ and Microbiological techniques. Nominations for the award, duly proposed and seconded with the consent of the nominee along with consent of the nominee along with six copies of his/her biodata, including a write upon the contribution of the nominee to Medical Microbiology should reach the IAMM secretary's office on or before 31st July 2016. The award carries a citation and a gold medal. The selected candidate must be prepared to deliver the oration at the National IAMM Conference held in 2017. Nominations must come by post/courier as a hard copy by the last date. Nominations received by fax or email will not be accepted.

4. Dr KB Sharma Memorial Junior Best paper award 2016: Nominations are invited for the Best paper award competition to be held at National Conference of the IAMM at Chandigarh in Nov 2016. This award is supported by the annual interest obtained from the fixed deposit, donated by the Dr. Urnil Sharma W/o Dr. K.B. Sharma. The contestant should be a member of IAMM, less than 35 years of age as on Aug 31, 2016 (certificate showing the proof of age should be

attached) and be the principle author of the paper. The same paper should not have received any other award or be published in any other award or be published in any journal and should be so certified, as a signed declaration by the contestant. The above mentioned declarations and six copies of the full paper complete with tables, figures, etc. (prepared according to the format of the IJMM) should reach the secretary's office on or before July 31st, 2016. The award carries a citation and a gold medal. The selected candidate will receive the citation and a gold medal at the valedictory function of the IAMM Conference Chandigarh in Nov 2016. Nominations must come by post/courier as a hard copy by the last date. Nominations received by fax or email will not be accepted.

5. Prof AN Chakrabarty memorial Prize for the best published paper in Mycobacteriology 2016 :

Any member, who has published a paper in the field of Mycobacteriology, during the preceding year i.e. 2015, in any National/ International journal will be eligible to submit paper for the award. The paper should not have received any other award and a declaration to that effect should be submitted while applying for the award. The above mentioned declarations and six copies of the full paper should reach the secretary's office on or before July 31st, 2016. The award carries a citation and a gold medal. The awardee will receive the award at the valedictory function of the IAMM Conference at Chandigarh in Nov 2016.

6. Prizes for the best papers during the IAMM Conference 2016 (total six categories listed below):

The following five prizes are given during the National Conference of the IAMM in Various categories:

1. NAWOPIA Dr. Pankajlaxmi V Venugopal Prize for the Best paper in Mycology.
2. Dr. SR Sengupta- Dr. AM Saoji memorial prize for the best paper in Immunology.
3. Dr. SS Kelkar Memorial prize for the best poster (any subject in Medical Microbiology).
4. IAMM silver Jubilee Prize for Best Paper in Parasitology.
5. Mumbai-Belgaum Prize for the best poster in Medical Mycobacteriology.
6. Belgaum-Mumbai Prize for the best paper in Bacteriology.

Nominations are invited for the above said prizes. Any IAMM member is eligible to contest for these awards. Abstracts for the award papers from interested members must be submitted to the IAMM Secretary's office. These will be subjected to peer review and only selected abstracts will be allowed to be presented as a paper at the respective oral/ poster sessions. The best paper amongst those will be adjudged the best paper by the panel of judges. The authors of an abstract must express their interest in a particular category while submitting the abstract. All the awards will be presented at the valedictory function of the IAMM Conference MICROCON 2016 to be held at Chandigarh in November, 2016.

**MINUTES OF THE GENERAL BODY MEETING HELD AT JIPMER PUDUCHERRY
UNDER THE CHAIRMANSHIP OF DR. J. SHANMUGAM AT 12.30PM ON 28th NOV., 2015 .**

The President, Dr. J. Shanmugam called the GB meeting in order and chaired the meeting. After calling meeting in order President informed that four members of our association namely Dr. C.S. Bhaskaran, Dr. Suniti Solomon, Dr. N.P. Gupta and Dr. S.C. Sanyal have passed away during the last year, he requested the members to observe a silence of one minute in remembrance of the departed souls. He further informed that on behalf of IAMM a letter of condolence will be sent to the grieved families. After the condolence meeting was adjourned and after five minute the members reassembled again to discuss the following agenda-

1. To confirm the minutes of EC meeting

Dr. M.B. Nagamoti, Secretary read the minutes of the last General Body meeting held at Jaipur and the same was confirmed by the house. The motion of confirmation was proposed by Dr. V. Ravi and seconded Dr. Abhay Chowdhary.

2. Secretary's Annual Report and Statement of Expenditure 2015- Dr. M.B. Nagamoti

The house ratified the annual secretary report read by Dr. Nagamoti during the inauguration function of the IAMM 2015 on 27th November 2015. The motion was confirmed by Dr. Chand Wattal and seconded by Dr. Shiva Prakash

3. Editor's annual report and statement of accounts- Dr. Arti Kapil:

Dr. V. Balaji read the report on behalf of Dr. Arti Kapil, Chief Editor, IJMM as she couldn't attend the meeting due to some urgent domestic reason. Report was deliberated. In the house Dr. Arunloke Chakarbarti enquired regarding duration of reviewing of the subscription of IJMM as the subscribers should pay money to IAMM for at least three years. Dr. Ravi enquired whether there is any concrete plan to increase the impact factor of the Journal. Dr. Balaji informed that due to inclusion of brief communications and case reports the impact factor of Journal is going down. He further suggested that the experts/Senior Members of the association should submit the review/original articles and he stressed that rejection rate of article needs to go-up for increasing the impact factor. Dr. Abhay Chowdhary suggested that editor of Journal should request experts to write the review articles and case reports should not be accepted. Dr. C.S. Patil said that we should try to get more articles. Dr. J. Shanmugam, President said that impact factor also depends on numbers of readers reading the

journal and citing the articles. He further suggested that only original articles need to be accepted and we should restrict the case reports and brief communications. Dr. Reba Kanungo commented that rejection rate should be very high and IAMM members should be encouraged to cite the IJMM articles particularly youngsters. One of the member commented that waiting period for publishing the article need to be decreased to encourage the submission of original articles. Dr. B.L. Sherwal suggested that the editor should write a letter to Medical Council of India regarding giving weight-age to the corresponding author as at present weight-age is given only to 1st and 2nd authors. The editor report was confirmed by Dr. C.S. Patil and seconded by Dr. Chand Wattal.

4. Treasurer Report- Dr. Anju Kagal

Dr. Anju Kagal, Treasurer presented the treasurer report. She said that state chapter members should be member of the IAMM to attend the chapter meet. She also said that the chapter using the PAN of IAMM should contribute 10% of their saving from donation to IAMM and in future state chapter should try to have their own PAN numbers and constitution. Dr. Abhay Chowdhary commented in response to the comment of the treasurer regarding chapter having their own constitution / PAN no. He suggested that chapter should have connection with IAMM and should not have their own constitution; the chapter should follow the constitution of the main body and work within the limitation of the same. Dr. Arunloke Chakarbarti suggested that a committee may be formed to look into the matter. The president agreed for the same and the subcommittee of the following members was constituted -

The members were requested to submit the report in the next general body meeting.

Dr. Kagal informed that signed copy of the IAMM constitution is required by the CA but it is not available with her.

The former presidents / Executive members were requested to look into the record if any available with them. Most of the members present informed that it is difficult to find the signed copy of the constitution. However, the following was suggested by the members:

- i. Dr. Shrinivas, founder member and the former president may be requested to provide the signed copy.
 - ii. Signed copy may be procured from registrar office through RTI, Dr. Arti Kapil may be requested to file an RTI for the same.
 - iii. Constitution may be redrafted and passed in the next General Body Meeting.
 - iv. The constitution copy may be got notarized from the court.
- The president stressed that we should archive our document in digital form.

The members were concerned about the income of the association, Dr. Kagal informed that the income of the association in the last financial year was decreased due to low interest rate accrued. Dr. Kagal informed that Dr. Bharti Malhotra, Organising Secretary of MICROCON 2015 donated Rs. 5 Lacs from saving of the conference. The house appreciated and thanked Dr. Bharti. The treasurer proposed that secretariat help of Rs. 5000 per month to treasurer office may be considered. Dr. B.L. Sherwal also requested that the secretariat help of Rs. 5000 per month should also be considered for Secretary office. The proposal of secretariat help @ Rs. 5000/- per month for secretary and treasurer office was agreed by the house. The treasurer report was confirmed by Dr. Pratibha Narang and seconded by Dr. M. Vegad.

5. Report of IAMMEQAS –Co-ordinator:

The secretary informed that in the EC meeting, south centre of the EQAS has shown their inability to continue, the executives have to request them to continue till 2016. However, they have not agreed to continue. General body was of the opinion that they should be requested to continue till January 2017. Secretary further informed that Dr. Balaji has agreed to run the south EQAS centre at CMC Vellore and he will be confirming within next one month and same was agreed by the GB. It was also decided that CMC Vellore should write a letter to NABL for accreditation.

Dr. M.K. Lalitha one of the NABL lead assessor said that EQAS centre should have PT provider as per ISO 15189: 2012 and centre should participate in another reputed EQAS programme. She further suggested that there should be a feedback mechanism. The working of north centre of EQAS at Sir Ganga Ram Hospital, New Delhi was appreciated by the GB. The EQAS report was accepted and confirmed by Dr. Pallab Ray and seconded by Dr. Sonal Saxena.

GB discussed the various topics as IAMM symposium and approved the topic as “MICROBIOME” to be moderated by Dr. Arunloke Chakarbarti and Dr. Pallab Ray.

8. Selection of topic/ Co-ordinator for the IAMM student symposium 2016

GB discussed the various topics as IAMM student Symposium and finalised the topic of “Infections in ICU” to be co-ordinated by Dr. Anju Kagal.

9. Election of office bearers for the year 2016 (Nominations invited to the Post)

10. Confirmation of venue for the MICROCON 2016: PGIMER Chandigarh

GB approved the venue of the MICROCON-2016 as PGIMER Chandigarh to be organised by department of Microbiology. Dr. Pallab Ray will be Organising Secretary and Dr. Arunloke Chakarbarti will be Organising Chairperson. Dr. Arunloke Chakarbarti formally invited the members to reach Chandigarh MICROCON 2016 in large number. Dr. Pallab Ray, Organising Secretary informed that there is a contest for finalising the theme of the conference. He requested the members to suggest the theme for the upcoming conference, the winner of the contest will be duly acknowledged.

11. Any other agenda:

Dr. M.B. Nagamoti has offered his services to update the IAMM website. Dr. Sherwal suggested that there should be a three members committee for updating of the website. The committee should have Secretary and two other members. Therefore it was agreed that alongwith Dr. B.L. Sherwal, Dr. Nagamoti and Dr. Vikas Manchanda will be responsible for updating the website.

OBITUARY

Dr. S.C. Sanyal



1942-2015

Dr. S. C. Sanyal, one of the leading Microbiologists of India, has passed away on 5th August 2015. He was born on January 1, 1942 in Mymensingh, Bengal, India. He did his MBBS from Nil Ratan Sircar Medical College, Calcutta, 1966 and PhD (1969) from Calcutta University while working at CSIR-WHO International Reference Centre for Vibrios, Indian Institute of Experimental Medicine, Kolkata.

Subsequently, he worked as Assistant Professor (1970) and Professor and Head (1979), Department of Microbiology, Institute of Medical Sciences, Banaras Hindu University (BHU). He obtained his MD from BHU in 1974, FAMS in 1984 and FRC Path (London) in 1992. In 1992, he moved to Kuwait as Chairman and Director of Laboratory Medicine and Senior Consultant Microbiologist of Specialized hospitals and retired from there in 2002.

Prof. Sanyal taught clinical microbiology to undergraduate and postgraduate students both as Faculty Member at BHU and at Kuwait University. He published more than 200 original research papers and guided 14 PhD students. He was honorary senior international scientist ICDDR, Dhaka, Bangladesh, 1981-1984. He served as President, Asia-Pacific Section, International Society on Toxicology and the Association of Microbiologists of India. He organised Annual Conference of Indian Association of Medical Microbiologists (IAMM) in the year 1985 and meeting of International society on Toxicology (IST) Asia Pacific Section in 1990, as Organising Secretary at Banaras Hindu University. He served as Advisor in a number of scientific bodies including ICMR, CSIR, WHO, and MOHFW, Govt. of India.

Prof. Sanyal has made outstanding contributions in medical microbiology especially Enteric bacteriology for which he was conferred the Shakuntala-Amirchand Award by the Indian Council of Medical Research (1970), Dr SC Agarwal Award by the Indian Association of Medical Microbiologists (1989), Ranbaxy International Research Award in Medical Sciences (1991), VR Kanolkar Oration Award by the National Academy of Medical Sciences, India (1992), Dr Bashambarnath Chopra Oration Award by INSA (1992). He was elected Fellow of the Royal Society of Tropical Medicine, Royal College of Pathologists, International Academy of Medical Sciences, National Academy of Medical Sciences, and Indian Academy of Sciences, Bangalore.

He is survived by his wife Mrs Kalyani Sanyal, daughter Rubella and son Rupan.

Proceeding of 39th National Conference held at JIPMER, Puducherry
